

## PNA Village Membership Agreement

This Agreement of Membership is entered into by and between the undersigned "Member" and PNA Village, a program operated by the Phinney Neighborhood Association (PNA).

**PNA Village Mission:** The PNA Village enriches aging and quality of life in our neighborhood by creating an intergenerational, diverse community that supports interdependence, security and shared experience.

**Membership & Fees:** In addition to PNA Village services and activities, your membership also includes membership in the Phinney Neighborhood Association. Membership runs for twelve months beginning from the date of payment. The annual fee may be increased from time to time, and annual membership may be renewed subject to agreement between the PNA Village and Member upon receipt of the fees listed at the time of renewal.

**Termination of Agreement:** The PNA Village reserves the right, at its sole discretion, to terminate this agreement at any time if the PNA Village determines that it is in the best interest of the PNA Village, its volunteers, other Members, or the undersigned Member(s). If the PNA Village terminates this agreement, it will return a portion of the annual membership fee paid on a pro-rated basis for the month of termination. The undersigned Member(s) may terminate this agreement at any time by providing written notice to the PNA Village. If this agreement is terminated by the Member, no portion of the annual fee will be refunded.

**Privacy Policy:** Confidentiality is very important to the PNA Village. The PNA Village will take all reasonable steps to protect the personal information of its members. However, where concerns regarding a Member's health or safety arise, the PNA Village reserves the right to contact the individual(s) listed as non-member contacts or other appropriate people, as determined by the PNA Village. In addition, to connect a member with a third-party vendor at the Member's request, the PNA Village may disclose contact and other relevant information.

**Release and Waiver of Liability:** To the extent permitted by law, I agree to indemnify and hold the PNA Village program, together with the agents, owners, employees, volunteers, and all other persons or entities acting in any capacity on its behalf, and the PNA (hereinafter the "PNA Village Released Parties") harmless for any loss, expense, or liability arising in any way out of their activities, including but not limited to any action I, my heirs and assigns, or my insurance company might bring for negligence, personal injury, or invasion of privacy.

As a Member of the PNA Village, I understand that neither the PNA nor the PNA Village is affiliated with the third party vendors it identifies as Preferred Vendors or Partially Vetted Vendors, and I release the PNA Village Released Parties from all responsibility or liability stemming from the conduct, service or product of such third party vendors.

As a PNA Village Member, I understand that the PNA Village is not a provider of emergency services or a health-care provider or administrator and does not employ licensed health professionals or social workers. This agreement is not meant to create any special relationship which would give rise to a duty to aid or protect between myself and PNA Village Released Parties.
